For example: Food Safety Inspection Service. (2002). Freezing safety policy. (USDA Publication No. 23-9890). Washington, DC: USDA Printing Office.

Give an abbreviated version of the policy's name enclosed in quotation marks and parentheses to begin your in-text citation. For example: T-shirts are not permitted ("Indianapolis").

List the title of the policy document, followed by a period. Only capitalize the first letter of the document's title. Make sure that the title appears in italics. List the volume number only if you are citing a multivolume work.

List the full title of the brief in italics, followed by a period. List the policy number in parentheses, if available. Capitalize only the first letter of the title, along with the first letters of any proper nouns. For example: *How Europe can muddle through its crisis* (Policy brief 10-27).

For in-text citations, use the author's last name, followed by a page number if it is available. If a page number is not available, use only the author's last name. For example: The policy is intended to "boost company morale" (Smith). If the author is unknown, use the name of the organization that the policy is written for.

To cite paraphrased material in the text of your paper, put the author's last name in parentheses at the end of the sentence where the paraphrase appears. Place a comma after the author's name, then type the year the source was published. Place the period ending the sentence after the closing parentheses mark.
